# INSURANCE COVERAGE REQUIREMENTS \*\*MUST HAVE THE FOLLOWING\*\*

#### **ROAD UNITS MUST HAVE THE FOLLOWING:**

- **1. Insured:** The lessee's name must appear as it does on the request form, with any subsidiaries noted.
- **2. Certificate Date:** The certificate date must be within the past 6 months.
- 3. Policy Expiration Date: Must be current to within (1) month from the rental start date.
- **4. Certificate Holder**: Thermo King West Inc. DBA Force TK, 8800 W Buckeye Rd., Tolleson, AZ 85353

### 5. Auto Liability Coverage:

- A. Minimum limits of \$1 million "Bodily Injury" (BI) and \$250,000 "Property Damage (PD) or the preferred \$1 million "Combined Single Limit."
- B. The certificate should indicate "Any Auto," "Owned," "Non-Owned," "Hired" or all of the aforementioned, by checking the appropriate box(es).
- C. If "Specified" or "Selected autos" is checked, the unit number, serial numbers and replacement value must appear on the certificate.

#### 6. Commercial General Liability Coverage:

- A. A minimum limit of \$1 million general aggregate.
- B. Any "Each Occurrence" limit, if any, must be at least \$1 million.

## 7. Property Damage and Physical Damage Coverage:

- A. Evidence of Property & Physical Damage Coverage must be for the **Full Replacement Value** of the unit, with a maximum deductible of \$1,500.00.
- B. Property Coverage must be listed on the certificate separately from Physical Damage coverage under part of General or Automobile Liability coverage.
- C. Coverage must include losses due to **Collisions**, **Fire**, **Theft and any other casualtv**.
- D. Thermo King West Inc. DBA Force TK must be listed as "Loss Payee."
